

Emerging Focus on Legal Barriers

The VA has recognized the importance of providing support to legal services aimed at Veterans:

- VA's Supportive Services for Veterans and Families (SSVF) grant includes legal services in the list of benefits supported by grant dollars. HVRP HFVVWF grant (urban and non-urban) now allows funds for legal assistance.
- Several VA Health Care Systems have allowed on-site legal clinics and legal professionals serving low-income veterans in the past few years.
- The VA has placed Veteran Justice Outreach (VJOs) in VAHCS to help veterans navigate involvement with the criminal justice system. Re-entry specialists do outreach to veteran prisoners to connect them with benefits and services available for them in their transition back to the community.



Child Support Issues

VIETNAM ERA VETS

- High instance of unmodified orders, many covering decades in which the vet was disabled or otherwise unable to work.
- Unlikely to contact child support or case management systems for assistance.
- Many have arrears only cases and owe a large amount of fees and penalties for past nonpayment.
- High instance of interstate cases.

OIF/OEF/OND VETS

- Experiencing high rates of divorce and family law involvement.
- Education and assistance can prevent them from owing tens of thousands in the future.
- Many interstate cases.
- Imputed income based on combat or contractor pay.
- High levels of unemployment.

Criminal Expungements

- Expungement = sealing records
- Laws vary by states, but most have severe restrictions
 - Challenge of sealing criminal convictions
 - Administrative v. Judicial records
 - Subject-matter limitations (in MN)
 DUI/DWI

Registration-based offenses

 Rarely accomplishes "new beginning" sought by veteran.

Consumer Law Tips

- Veterans benefits are exempt from most debt collectors.
- Servicemember Civil Relief Act (SCRA) provides protections to active duty and deployed servicemembers.
- Many veterans struggle with the decision to not repay debts and instead use resources needed for self-sufficiency to reduce debt.

Veteran-specific Employment Law

USERRA – The Uniformed Services Employment and Reemployment Rights Act

- Right to be reemployed in civilian job if job left for military service
 Requires written or verbal notice to employer
 - Must apply for reemployment in a timely manner after conclusion of service Requires separation from service with discharge under honorable conditions Limited to 5 years or less of cumulative service while with same civilian employer
- Right to be free from discrimination and retaliation based on service
- Right to continue health care coverage through civilian employer for up to 24 months while in the military.
- Right to reinstate civilian employer health care coverage when reemployed

Benefits for Veterans

VA benefits

- Administrative process rarely involving attorneys until VA appeals are exhausted and denial appealed to Federal District Court.
- Not quick; benefits once approved are paid as of the date of filing for the benefits.
- If overpayment made, Veteran may temporarily or permanently lose benefits.
- Attorneys must be admitted to practice before the Court of Veterans Appeals.

Non-VA benefits

 Interplay between non-VA and VA benefits—some benefits may result in a dollar-for-dollar loss of other benefit sources.

Creating a Legal Program

- Spectrum of possible legal components
 - On-staff attorney providing full rep
 - On-staff attorney coordinating pro bono effort and/or legal services relationships
 - Contract relationship with legal services for full rep and/or pro bono assistance
 - Collaboration with legal services (unfunded)
- Identifying veterans
 - Community-based legal clinics
 - Program participants
 - Community partners and VA homeless programs
